

Stonecom Contest Rules



Contest: Ford Lincoln of Cookeville Game Day Tailgate

Station: WBXE Rock 93-7 and WKXD 106-9 Kicks Country

Section One: How to Enter the Contest

1. Fill out an official contest entry form completely at any Ford Lincoln of Cookeville Game Day Tailgate.
1. Place official entry blank in contest registration box .
2. Only ONE entry per person.
3. Opportunities to enter will be at:
 - a. Saturday, September 1st from 1-3pm at Ford Lincoln of Cookeville to win a pair of tickets to the UT vs. UTEP game.
 - b. Saturday, September 29th, time TBA, at Ford Lincoln of Cookeville to win a pair of tickets to the UT vs. Charlotte game.
 - c. Saturday, October 13th, time TBA, at Ford Lincoln of Cookeville to win a pair of tickets to the UT vs. Alabama game.
 - d. Saturday, October 27th, time TBA, at Ford Lincoln of Cookeville to win a pair of tickets to the UT vs. Missouri.

Section Two: Eligibility Restrictions

1. The contest is open to all Stonecom listeners who are legal United States citizens who reside in Stonecom listening area of Middle Tennessee.
2. Employees of Stonecom, its licensee, Stonecom, their subsidiaries, affiliated entities affiliated advertising agencies, participating sponsors/promotional partners (Ford Lincoln of Cookeville, Nissan of Cookeville, or Hyundai of Cookeville), other radio stations in the Middle Tennessee listening area and the members of their immediate families are ineligible to participate or win.
