

Stonecom Contest Rules

Contest: Lunchtime Rapid Rescue

Station: 106.9 Kicks Country

Section One: How to Enter the Contest.

1. Beginning Monday, May 16th, 2022, the contest will begin for the chance to win a prize.
2. You must be 18 years of age or older to win.
3. Firehouse Subs is the sponsor.
4. The Prize is defined as lunch for 10 from Firehouse Subs delivered by Billy.
5. Winners will be chosen from total entries received within allotted nomination times in the specified window of 5/16/22 – 12/29/22.
6. Listeners can qualify by calling-in to the hosting station when prompted, submitting an entry through the station Facebook page, or submission via the station's specific website.

Section Two: Eligibility Restrictions

1. The contest is open to all Stonecom listeners who are legal United States citizens who reside in Stonecom listening area of Middle Tennessee.
2. Employees of the local businesses involved, Stonecom, its licensee, Stonecom, their subsidiaries, affiliated entities, affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Middle Tennessee listening area and the members of their immediate families are ineligible to participate or win. Immediate family shall include spouse, parents, children, siblings, grandparents, grandchildren and any other person residing within the same household.
3. Listeners are eligible to win a Stonecom contest only once every thirty days.
4. Only one winner or qualifier per family per household is permitted in any contest.
5. Must be 18 years of age or older to win.
6. There is no age minimum for the person nominating a potential winner.
7. No one employed at the sponsoring company is eligible.

Section Three: Prizes

1. There will be a limited number of prizes available for winning, set before the contest.
2. Contest prizes are not transferable.
3. Prizes may not be substituted for or redeemed for cash. No cash back available.

2. Each Winner will receive a Prize.
3. Qualifiers will be determined by station choice of nominees which have been submitted through the station website, media page or by calling in to the station show when prompted.
4. All nominations are eligible to become qualifiers to win a Prize.
5. Winners will be contacted by a station representative on how to receive the prize.
6. The Stonecom Promotions Department reserves the right to make changes to the winner selection process without notice.
7. All contest decisions are final.
8. Must be present at time of call to win.
9. If unavailable to call, no Prize will be awarded.
10. If unavailable to call, Stonecom will select a new qualifier.

Section Five: Conditions

If due to circumstances beyond the control of Station, any event associated with this contest or the prize is delayed, rescheduled, postponed or cancelled, Station reserves the right, but not the obligation, to cancel or modify the contest and shall not be required to award a substitute prize.
3. No purchase is necessary. The contest is void where prohibited. Must be 18 or older to win.
